On May 22, 2007, SPECIAL AGENT (SA) WILLIAM P. DELANEY met with the SOURCE at a pre arranged location. The SOURCE stated he had telephonically contacted TIM BALDUCCI on May 21, 2007 to discuss the Order Compelling Arbitration in the matter of JONES, FUNDERBURG, SESSUMS, PETERSON AND LEE, LLC versus RICHARD SCRUGGS et al which BALDUCCI had faxed to the SOURCE on May 4, 2007. An FD-302 was written to this file by SA DELANEY on May 24, 2007 regarding the consensually recorded telephone conversation.

Subsequent to the telephone conversation with BALDUCCI, the SOURCE sent by fax a letter to LARRY MOFFETT, GRADY TOLLISON and the MISSISSIPPI STATE SUPREME COURT on May 21, 2007.

The SOURCE provided a copy of the letter to SA DELANEY. The original copy of the letter will be maintained in the Confidential file, a redacted copy is attached to this FD-302 and is made a part of the substantive file.
